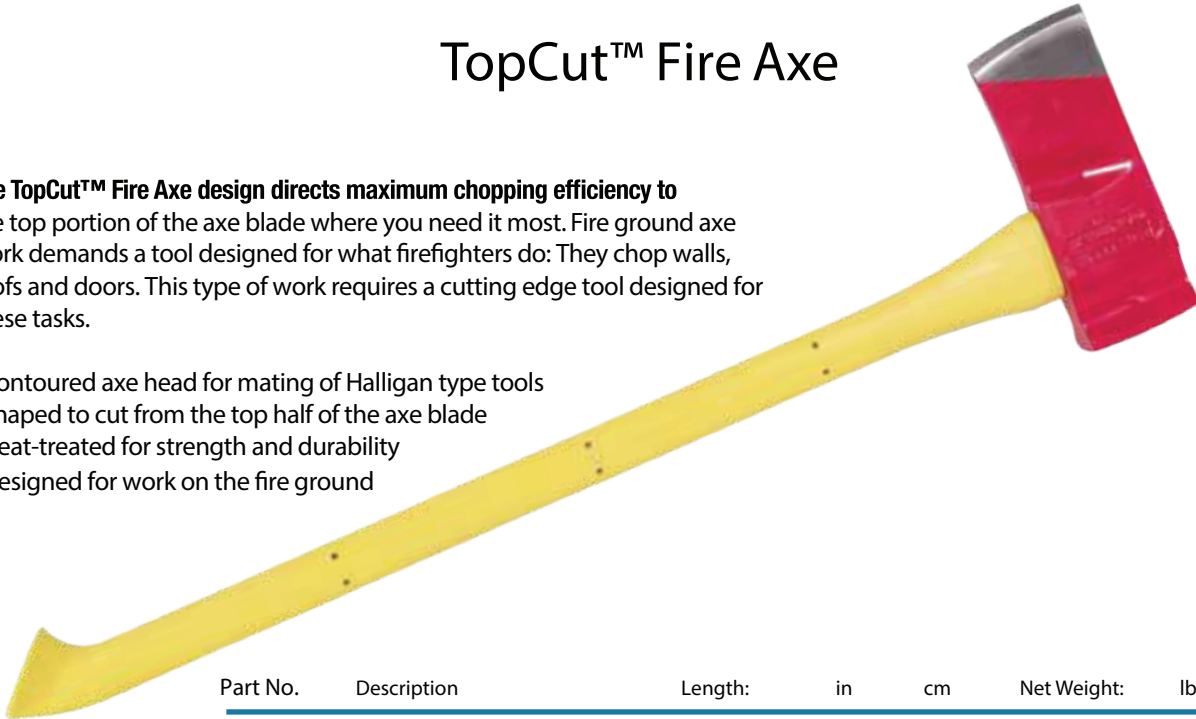


TopCut™ Fire Axe
